Sub: DFFT scheme 2020-21 - One year long term program on "Master in Public Administration (MPA)" at Lee Kuan Yew School of Public Policy, National University of Singapore.

Sir/Madam,

Department of Personnel and Training (DoPT), Training Division, Govt. of India vide their circular dated 28.10.2019 has invited applications/nominations for one year long-term training programme on Master in Public Administration (MPA) at Lee Kuan Yew School of Public Policy, National University of Singapore under DFFT Scheme to be conducted during Financial Year 2020-21. The aforesaid circular may be downloaded from the website of Ministry of Personnel, Public Grievances and Pensions i.e. <http://dfft.nic.in>

The proposed eligibility for the above said course, as mentioned in above said DoPT circular dated 28.10.2019, are as under : -

(a) Service eligibility :-

- (i) IAS officers, CSS/CSSS officers and officers of State Civil Service irrespective of their place of posting;
- (ii) Other AIS (IPS, IFoS)/Group 'A' Central Civil Service officers during the tenure of deputation under Central Staffing Scheme of DoPT;

(b) Minimum length of service as on 1st July, 2020 :-

1. IAS officers who have completed 7 years of service;
2. Other AIS (IPS and IFoS) officers and Group 'A' Central Civil Service officers who have completed 9 years of service;
3. State Civil Services (SCS) officers who have completed at least 9 years of service from the date of joining as Deputy Collector;
4. CSS/CSSS officers who have completed 5 years of service in Group 'A' including as under Secretary/PPS.

(c) Upper age limit as on 1st July 2020: 48 years :-

(The above eligibility conditions are proposed for 2020-21 and therefore, subject to approval of the competent authority).

It is requested that willing/eligible officers may take necessary action as per the contents of the aforesaid circular and may send their application 'online' to the Ministry, under intimation to this department latest by 31.12.2019.
