ORDER

Whereas, Sh. Kumar Praveen, Stenographer, Trade & Taxes Department was placed under suspension by the Commissioner, VAT vide order No.F.11(55)/2013/Vig./DTT/595 dated 05/08/2013.

And whereas, the suspension of Sh. Kumar Praveen, Stenographer was extended further from time to time.

And whereas, Sh. Kumar Praveen, Steno. has now filed an appeal dated 02/12/2014 under Rule 23 (i) of CCS (CCA) Rules, 1965 before the undersigned against his suspension on the following grounds –

- i) During the joint surprise checking of CBI carried out on 26/07/2013 in the Enforcement Branch-II, the table from where the amount of Rs.40000/- alleged to have been recovered, in fact, did not belong to him. The said table was a common table used by all the staff of Enforcement-II Branch as well as Transporters visiting the office. Furthermore, he was not present on the spot at the time of recovery.
- ii) He was neither caught red-handed nor the CBI disclosed the name of the Transporter from whom the said amount was received by him on behalf of Sh. Sohan Lal, AVATO.
- iii) The CBI falsely implicated him in the fabricated case, concealing the factual position.

And whereas, I have gone through the facts and circumstances and record of the case, and also the submissions made by the Appellant, and noted that the Appellant has already been charge sheeted under Rule 14 of CCS (CCA) Rules, 1965 vide charge Memo. No.F.5(82)/2013/DTT/PF-I/509 dated 03/06/2014. The Inquiry Officer and Presenting Officer have also been appointed in the case vide orders dated 21/07/2014. Since the disciplinary proceedings have already been initiated against the Appellant, I am of the considered opinion that his suspension should be revoked, without prejudice to the outcome of the disciplinary as well as criminal proceedings against him. However, he may be posted in a non-sensitive/non-public dealing department till the conclusion of the proceedings against him.

It is ordered accordingly.

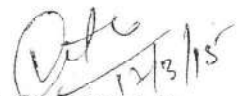
