Madam/Sir,

The Assured Career Progression Scheme (ACP) has been implemented by Govt. of NCT of Delhi as per the instructions of DoPT, GOI vide OM No. 35035/1/97-Estt (D) dated 09.08.1999. The scheme has been endorsed by Finance Budget Department, Govt. of NCT of Delhi vide order No. F.14(2)/99-Fin(B) dated 27.08.1999 and accordingly, 1<sup>st</sup>/2<sup>nd</sup> financial upgradation are considered by the designated Screening Committee on completion of 12/24 years of regular service without any/one promotion. The ACP scheme was operational from 09.08.1999 to 31.08.2008.

The ACP Scheme has been replaced by Modified Assured Career Progression Scheme (MACP) w.e.f 01.09.2008 vide DoPT, GOI vide OM No. 35034/3/2008-Estt (D) dated 19.05.2009. The scheme was endorsed by Finance Budget Department, Govt. of NCT of Delhi vide order No. F.11(4)/2006-Fin(B)/PT.II/dsfb/1192-1297 dated 27.05.2009 to grant three financial upgradation at interval of 10,20 & 30 years of continuous regular service.

ACP Cell, Services Department is processing ACP/MACP cases of DASS/STENO Cadre Officers/officials. The financial upgradation under ACP/MACP Scheme is due as under:

2 <sup>nd</sup> ACP/ MACP	On completion of 24 years of regular service on or before 31.08.08 with one promotion/financial upgradation OR			
	On completion of 20 years of regular service on or after 01.09.2008 with one promotion/financial upgradation.			
3rd MACP	On completion of 30 years of regular service on or after 01.09.2008 with two promotion/financial upgradation.			

During processing of ACP/MACP cases it was noticed that the ACP/MACP benefits are due to the Officers/officials long back implying that the ACP/MACP cases are not being forwarded by the Administrative Department on time.

Therefore, all the Administrative Departments are hereby requested to identify the Officers/officials whose ACP/MACP benefits have already been accrued and to forward their service particulars to this Department in the enclosed performa within ten days. The cases in which the MACP benefits are to be accrued by December 2018 may also be forwarded as per instructions at Para 6 of DoPT, GOI, OM dated 19.05.2009.
