Subject: Publication of the Civil List of IAS Officers for the Year 2026 - Online Updation - Compilation of Data Reflecting Position as on 01.01.2026.

Sir/Madam,

I am directed to state that the process of compilation and publication of the 71st edition of the Civil List of IAS officers for the year 2026 has been initiated. The objective is to prepare the Civil List, 2026, reflecting the position as on 01.01.2026, on the basis of information updated by the State Cadres.

The points on which information is required to be furnished are reiterated below:

 Uploading of clear photographs of IAS officers, if not uploaded earlier, in JPG/JPEG format (size less than 20 KB).

A maximum of two qualifications; starting from B.A./B.Sc. etc., may be given in the Civil
List. The choice of two qualifications may be left to the officer concerned, which the State
Government may incorporate after consulting him/her. The terms "B.A./B.Sc./B.Com." etc.
should be used instead of "Graduate/Postgraduate/" and "Rh.D./D.Lift./M.Phil." etc. may
be mentioned instead of "Doctorate."

 Existing postings of the members of service during the year 2025 should be provided, as the CMI List 2026 will contain information as on 01.01.2026.

- Lepel of pay drawn by the members of service in the State Government should be indicated.
- Domicile of officers promoted to the TAS should be mentioned.
- Copies of orders/supporting documents relating to officers who have resigned, voluntarily retired, or expired during the year should be furnished.
- In case of officers on deputation under Rule-6(2)(II) of the IAS (Cadre) Rules, the date of Joining the deputation post should be provided.
- For officers on leave/study leave/training, the date of commencement of such leave/study leave/training should be provided.
- All transfers, promotions, and upgradations of pay made up to 61.01.2026 should be reflected in the information furnished.

- 3. Efforts have been made to compile full names of officers from records available in this Department. However, the State Governments and the Ministry of Home Affairs (for IAS officers of the AGMUT Cadre) are requested to verify the full names of officers and complete uncovered cases with the reports available with them. In case of discrepancies in expanded names, dates of birth, etc., the Section Officer, EO-CM, E.O. Division, DoPT, Kartavya Bhawan-3, New Delhi (Tel. No. 011-24010478) e-mail; socm-dopt@nic.in; with copy to rishabh.92@gov.in and kavitachauhan.edu@nic.in) may be contacted. For discrepancies relating to seniority, the Section Officer, AIS-III Section, DoPT, Kartavya Bhawan-3, New Delhi 119001 (Tel. No. 011-24010460; e-mail; rishabh.92@gov.in; kavitachauhah.edu@nic.in) may be contacted.
- NIC, DoPT has provided a modified/updated offline web-based software for updating the Data Bank of TAS officers' present posting details along with photographs through the Internet. State Sovernments are requested to update the requisite information. A copy of instructions for entering/updating data for the Civil List online is enclosed for reference. As regards registration and updation of the Civil List, the State Governments are requested to follow the enclosed instructions manual. It is imperative that updation is undertaken only by duly authorized personnel.
- For editing the Civil List pertaining to your State, the assistance of the State Unit of NIC may be taken. In case of any technical difficulty, clarifications may be sought from the NIC, Dopt Computer Centre, Kartavya Bhawan-3, New Delhi (e-mail: persinforech@nic.in): 6. It is emphasized that the facility for updation/correction of the online Civil List pertaining to State Cadres is available on the Ministry's website (dopt.gov.in IAS Civil List). A copy of the updated list may kindly be sent to this Department, by post, by 15th December, 2025. Since the Civil List, when published, should reflect the position as on 01.01.2026, changes, if any, made between 16.12.2025 and 01.01.2026 will be incorporated based on data made available to this Department. Members of the Service may accordingly be informed to verify their details and correct discrepancies, if any.
- 7. Considerable accuracy was achieved in the e-Civil List, 2025 due to the cooperation received from the State Governments, MIC State Units, and NIC-DoPT Computer Centre. The endeavor to bring out a zero-error Civil List for 2026 can be successful only with full cooperation from all concerned.
- 8. All State Cadres are requested to nominate authorized personnel and complete the registration process as per the instruction manual before 24th October, 2025 for entering/updating the data in the e-Civil 11st, 2026.
- The authorities concerned may be suitably directed to extend full cooperation in this regard.
