Sir/madam,

I am directed to refer to this office letter dated 16.01.2025 and subsequent reminder dated 08.04.2025, 19.05.2025, 09.06.2025 & 24.06.2025 wherein it has been requested to provide the requisite documents/information such as undertaking for willingness/Non-willingness, Integrity Certificate, Vigilance Clearance Certificate Report, Details of Penalties in respect of the eligible officers of feeder category for induction into DANICS for the vacancies pertaining to the year 2025. However, the requisite details in respect of the officers mentioned in Annexure -I & II has not been received from your office till date.

In this regard, the Ministry has informed that the process of Induction to DANICS for VY 2025 has been delayed for the want of information/documents from the Govt. of NCT of Delhi. Therefore, Services Department, GNCTD may issue stern instructions to all eligible feeder grade officers to provide their willingness to be inducted to DANICS for VY 2025 by 21.07.2025. Further, non-receipt of willingness will be assumed as non-willingness to be inducted to DANICS.

Further, it has been directed to furnish the requisite information/documents of willing feeder grade officers of DANICS to the Ministry latest by 23.07.2025.

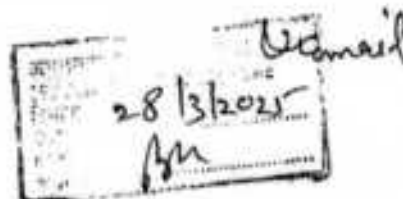
