I am directed to refer to this office letter dated 06.11.2025 with subsequent reminder dated 03.12.2025 vide which the letter No.F.14016/05/2016.UTS-I dated 31.10.2025 & reminder-I dated 13.11.2025 of Ministry of Home Affairs, Gol was circulated in r/o SCS officers (PCS and DANICS) figuring in the zone of consideration for convening Review Selection Committee Meeting for the Select Lists of 2015, 2016, 2017 and 2018, respectively for promotion to the IAS of Joint AGMUT Cadre (UT Segment) in terms of DoP&T's Notifications dated 12.08.2025 and in compliance of Hon'ble CAT, PB, New Delhi's Order dated 21.02.2017 in OA No.3122/2015 with the request to furnish requisite information/documents in respect of eligible officer to this office for onward transmission to MHA, Gol.

2. In this regard, it is informed that only few information/documents have been received in this office (**copy of status of information/documents received in this office is enclosed**).

Therefore, it is again requested to furnish the following declarations (**original signed**) in respect of eligible officers for onward transmission to the Ministry for further appropriate action:-

- (iii) Consent for termination of lien in the State Civil Service after his substantive appointment to IAS (Those who have not inducted into IAS).

- IX. Certificate regarding communication of adverse remarks in respect of the officer [information may be provided in the requisite proforma enclosed (Annexure 6)].
- X. ACR validation certificate (Annexure-7)
- XI. Statement of ACRs in respect of the officers [information may be provided in the requisite proforma enclosed (Annexure 7.1)].

XII. Details of Court cases and Court orders having bearing on the Select List [information may be provided in the requisite proforma enclosed (Annexure 8)].
