Sir/madam,

I am directed to refer to letter No.14016/04/2025-UTS-II dated 13.05.2025 (copy enclosed) **LAST REMINDER** received from MHA, on the subject cited above and also refer to this office letters dated 16.01.2025, 08.04.2025 and 19.05.2025.

It is informed that this office vide letters dated 16.01.2025, 08.04.2025 & 19.05.2025 has forwarded a list of Grade-I Officer of GNCTD i.e. feeder cadre officers (Annexure - I & Annexure-II -SC/ST/PwBD) who will be in service on 01.07.2025, for induction into Entry Grade of DANICS against the vacancies pertaining to the year 2025.

Further, it is informed that despite giving the timeline of 29.05.2025 in this office vide letter (reminder - II) dated 19.05.2025 (copy enclosed), we have received documents of only few eligible officers. The status of receiving of information/documents in this office is as under:

It is again reiterated that the Ministry is pressing hard to forward the documents of eligible officers immediately to conduct the DPC within time for DANICS induction vacancy year 2025. However, this slow progress of receiving



of documents will delay the process of DPC and thus the eligible officers who are willing to be inducted into DANICS cadre will be deprived of getting benefit of induction on time.

This matter has been viewed seriously by the Principal Secretary(Services) and he is of the opinion that It is the duty of Head of Office of any department of GNCTD to comply with the directions of Services Department and it needs more seriousness when the matter is related to Ministry of Home Affairs, GoI.

Accordingly, it has been directed to furnish the requisite information/documents by the department concerned **by 12.06.2025** to this office without any further delay. In case of non-receiving of following information/documents (i,ii & iii) of eligible officers as mentioned in Annexure-I & II (Revised) action will be taken against the Head of Office (HOO) of department concerned for non-compliance of the directions. Further, after 09.06.2025, it will be assumed that non receiving of willing or non-willing certificate and documents from eligible officers mentioned in the Annexure-I and Annexure -II (Revised) will be assumed that they are non-willing for the said induction and treated as deemed refusal for the said induction.
