The Officials concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme. However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The concerned HODs may ensure before issue of final orders that the officials have not been given more than one financial up-gradation / promotion and completed 20 years of regular service for 2nd Financial upgradation during their tenure including past services at DEDA/DSMDC prior to re-deployment in GNCT of Delhi. Ad-hoc / temporary service period shall not be counted for grant of MACP benefits. Any financial up-gradation granted to the official without counting of past service at DEDA/DSMDC shall stand modified accordingly.

The concerned Head of Departments are requested to issue formal order for grant of the 2nd financial upgradation in respect of the above mentioned officials working in their Departments.
