The Official concerned may be allowed to exercise his options, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme. However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The Concerned HOD may ensure before issue of final orders that concerned official has not been given more than one financial upgradation / promotion and completed 20 years of regular service for 2nd Financial upgradation during their tenure including past services at DEDA/DSMDC prior to redeployment in GNCT of Delhi. Ad-hoc / temporary service period shall not be counted for grant of MACP benefits. Any financial upgradation granted to the official without counting of past service at DEDA/DSMDC shall stand modified accordingly.
