Sir/Madam,

Kindly refer letters dated 01/11/10, 03/12/10, 25/03/11, 28/02/12, 17/05/12, 04/07/12, 30/08/12, 02/01/13, 03/04/2013, 20/06/13, 21/01/14, 30/04/14, 27/08/14, 13/03/15, 31/08/15, 16/12/15, 26/02/16, 20/06/16, 07/07/17, 30/11/17, 11/09/18, 14/06/19, 17/09/19, 25/02/2020, 20/08/2020, 29/01/2021, 20/07/2021 & 25/05/2022 wherein it was requested to forward the Integrity Certificate, Vigilance Clearance Report, Type Test Report & Annual Confidential Reports of Grade-IV (GNCTDSS) officials for consideration of their promotion to the post of Grade-III (GNCTDSS).

Further, attention is invited to circular vide F.No.3(1)/(3)/2021/S-II/884-85 dated 22/03/2022 that has been issued by this department stressing about timely furnishing of service particulars of left out cases & detailing about the procedure of quarterly review DPC and furnishing of requisite documents before 06 months of retirement in case of retiring officials.

In this regard, I am directed to state that the lapse/omission on the part of the competent authority in issuance of IC/VC in time has deprived otherwise eligible officials from getting promotion to the next higher grade.

Moreover, it is intimated that in the absence of requisite service particulars/ACRs/APARs, it has become a near impossible task for this department to consider the cases of officials for promotion. As result, this department is being flooded with RTI applications/ litigations. Besides, providing of service particulars of an official, such as IC/VC/ACRs/APARs, is exclusively the subject matter of administrative department concerned.

However, despite best of efforts put in by the Services Department, the requisite information/documents in respect of these officials are yet to be received from the concerned administrative department.

Hence, list of Grade IV (GNCTDSS)/Jr. Assistant whose cases were deferred/placed in sealed cover by the earlier DPC/Screening Committee is being circulated for want of requisite documents alongwith supporting/relevant documents (where applicable) as mentioned against each in the attached Annexure-A.



Therefore, it is once again requested that to provide the service particulars in respect of officials mentioned in the attached Annexure-A, i.e., Integrity & Vigilance certificate( Annexure-B), Type Test Report & service particulars proforma(Annexure-C) alongwith Vigilance Clearance & No penalty certificate(Annexure-D) as on date of their notional promotion or penalty completion certificate within 03 weeks of issue of this letter for considering their cases for promotion to the post of Grade-III (GNCTDSS)/Sr. Assistant. .

If any of the official(s) (as per list attached) has expired/resigned/removed from service or in case where about not known, the necessary information may be provided to this department.
