The Official concerned may be allowed to exercise his option, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme. However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from his pay.

The concerned HOD may ensure before issue of final order that the official has not been given more than two financial upgradation / promotion and completed 10 years of regular service in same pay scale including past services at DEDA prior to re-deployment in GNCT of Delhi. Ad-hoc / temporary service period shall not be counted for grant of MACP benefits.

The concerned Head of Department is requested to issue formal order for grant of the 3rd financial upgradation in respect of the above mentioned official working in their Departments. However, before the issuance of the formal order the Heads of Departments may again confirm that the official has completed 10 years of regular service in same pay scale with two financial upgradation / promotion and is clear from Vigilance angle.
