The ends of justice in this case would be met by modifying the impugned penalty imposed upon the Appellant as "reduction to the lower post of Assistant Section Officer carrying pay at level 7, for a period of Five years, with further directions that the reduction shall postpone his future increments and on the expiry of the period he shall not regain his original seniority in the higher post of Section Officer."

And whereas, in compliance of above said order, Sh. Ved Prakash (DoB-08/05/70) Ex Gr-I (DASS) reported for duty in Services Department to the post of Gr-II (DASS) on 17/12/2021 (A/N).

Now, therefore, consequent upon his reporting for duty, the Competent Authority is pleased to post Sh. Ved Prakash, Gr-II (DASS)/ASO in Department of Industries w.e.f. 17/12/2021 (A/N).
