In view of the reduction in COVID-19 related cases and further relaxation in restrictions issued by DDMA vide their Order No. 518 dated 04.02.22, the Competent Authority is pleased to **Stand Relieve Forthwith** all Adhoc DANICS, Gr.-I, Gr.-II, Gr.-III & Gr.-IV (DASS) officers/officials, who have been deployed by Services Department or substituted by administrative departments for COVID-19 related duties in various departments of GNCTD viz. Revenue Department, Health Department, DAMB, Food Supply and Consumer Affairs Department etc. and are still continuing to work in COVID-19 related duties in the said departments, with the direction to report back to their parent departments/to the departments where they are physically posted without waiting for any formal relieving from their present place of deployment.

It is further ordered that in case any of the officers/officials does not report for duty in his concerned department, the administrative department would take appropriate action against the officer/official as per the extant rules and regulations under intimation to this department.
