On the recommendations of the Review Departmental Promotion Committee, the Competent Authority, under Rule 6 of DASS Rules 1967, is pleased to appoint the following Grade-IV (DASS) official to the post of Grade-III (DASS) by promotion in level 4 of pay matrix of Rs. 25500-81100 (Pre-revised Rs.5200-20200 with Grade Pay Rs.2400), notionally with effect from the date mentioned against his name at Column No.5 below:-

The above official may exercise his option with regard to fixation of pay, if any, as per FR-22 within one month of issue of this order.

Consequent upon his promotion, the aforesaid official is hereby transferred/posted in Chief Electoral Office against vacant post of Grade III (DASS) with immediate effect.

The Head of Department concerned should ensure that the aforesaid official was clear from vigilance angle and no penalty was in operation on the date of his notional promotion. Further the benefit of promotion will be admissible to the official only with effect from the actual date of his joining to the post of Sr. Asstt. /Grade-III (DASS).

Attention of Head of Department is also invited to the provisions of DoPT, Govt. of India OM dated 20/03/1995, stipulating therein to fix responsibility on Controlling Authority for relieving of government servant on his/her promotion within a period of three months in any case.

The Head of Department concerned may ensure that the aforesaid official, who has been transferred on promotion, is relieved with immediate effect with the direction to join his new assignment under intimation to this department. In case the official could not be relieved due to any reason, the same may also be intimated to this department immediately.

The aforesaid promotion is subject to outcome of the SLP (C) No. 30621/2011, SLP (C) No. 6915/2014 & SLP (C) No. 31288/2017 and other connected SLPs pending before the Hon'ble Supreme Court.
