The above named promoted officials may exercise option, if any, within one month in pursuance of the instructions of Government of India regarding fixation of pay as contained in FR-22.

However, above named officers are not entitled to the payment of pay & allowances for the period for which they have not actually worked as Grade-I (DASS). The benefits will be admissible with effect from the actual date of their joining to the post of Grade-I (DASS). They will avail the benefits of promotion on joining duty in the department in which they have been posted on promotion to the post of Grade-I (DASS).

Further, the promotion is subject to the condition that the Head of the Departments concerned must ensure that no disciplinary proceedings/criminal proceedings were pending or no penalty was in operation against the promotee officials on the date of their notional promotion before relieving them to take up their new assignment on promotion in the light of instructions contained in DoPT OM No.

22011/4/91-Estt(A) dated 14.09.1992 and other related OM's issued from time to time. The above said conditions related to vigilance clearance & status of penalty shall invariably be mentioned in their relieving order as well. Further, an undertaking in this regard shall also be obtained from the officials concerned by the administrative department concerned before relieving to their new assignment on promotion.

If any of the officials out of the above, is not clear from vigilance angle or his/her integrity is not certified as on date of their notional promotion or has resigned/expired/taken VRS etc., the same should be brought to the notice of this department immediately.

Attention of Head of Department's is also invited to the provisions of DoPT, Govt. of India, OM dated 20.03.1995, stipulating therein to fix responsibility on Controlling Authority for relieving of Government servant on his/her promotion within a period of three months in any case.

Further, in the light of instructions contained in para 5 of DoPT's OM No. 36012/16/2019-Estt(Res.) dated 12.04.2022, the promotion order shall be subject to further orders that may be passed by the Hon'ble Supreme Court of India in the Jarnail Singh batch of cases pending before the Hon'ble Apex Court.

Further, consequent upon their promotion to the post of Grade-I (DASS), the Competent Authority is pleased to order transfer/posting of the following officers against the vacant posts of Grade-I (DASS)/Section Officer in departments as mentioned against their names and with effect from the date as mentioned against their names, as given below:-
