The above mentioned official will continue to work in GNEC to the post of Grade-II/ASO, as usual.

The promotion is subject to the condition that the Head of the Departments concerned must ensure that no disciplinary proceedings/criminal proceedings was pending or no penalty was in operation against the promotee official on the date of his notional promotion in the light of instructions contained in DoPT O.M.
