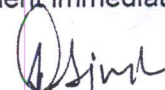
The above officials may exercise their option with regard to fixation of pay, if any, as per FR-22 within one month of issue of this order.

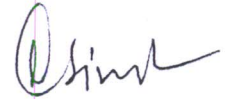
