ORDER NO. 43

On the recommendations of the Departmental Promotion Committee/Review DPC, the Competent Authority is pleased to appoint the following Grade-IV(GNCTDSS)/Jr. Assistant on promotion to the post of Grade-III(GNCTDSS)/Sr. Assistant in Level-4 of pay matrix of pay scale of Rs. 25500-81100 (Pre-revised Rs.5200-20200 with Grade Pay Rs.2400), notionally with effect from the date mentioned at Column No.5 under Rule-6 of DASS Rules, 1967:-

The official may exercise his option with regard to fixation of pay, if any, as per FR22 within one month from the issue of this order.

However, above named official is not entitled to the payment of any pay & allowances for the period for which he has not actually worked as Grade-III(GNCTDSS)/Sr. Assistant. The benefit of promotion will be admissible to the above mentioned official only with effect from the actual date of joining to the post of Grade-III(GNCTDSS)/Sr. Assistant in the Department in which he has been posted on promotion to the post of Grade-III(GNCTDSS)/Sr. Assistant vide this order.

Further, the promotion is subject to the condition that the Head of the Department concerned must ensure that no disciplinary proceedings/criminal proceedings were pending or no penalty was in operation against the promotee official on the date of his notional promotion i.e. 08/03/2022 before relieving him to take up his new assignment on promotion in the light of instructions contained in DoPT O.M. No.22011/4/91-Estt(A) dated 14/09/1992 and other related OMs issued from time to time. The above said conditions related to vigilance clearance & status of penalty shall invariably be mentioned in his relieving order as well. Further, an undertaking in this regard shall also be obtained from the official concerned by the administrative department concerned before relieving to his new assignment on promotion.

If the official, is not clear from vigilance angle or his integrity is not certified as on date of his notional promotion or has resigned/ expired/taken VRS etc., the same should be brought to the notice of this department immediately.

Consequent upon his promotion to the post of Grade-III(GNCTDSS)/Sr. Assistant, the Competent Authority is pleased to allow Sh. Vipin Tomar, DoB: 08/01/1987 to continue to work against the vacant post of Grade-III(GNCTDSS)/Sr. Assistant in Directorate of Education.

Attention of Head of Department's is also invited to the provisions of DOPT, Govt. of India, OM dated 20/03/1995, stipulating therein to fix responsibility on Controlling Authority for relieving of government servant on his promotion within a period of three months in any case.

Further, In the light of instructions contained in para 5 of DoPT's O.M. No.36012/16/2019-Estt.(Res.) dated 12/04/2022, the promotion order shall be subject to further orders that may be passed by the Hon'ble Supreme Court of India in the Jarnail Singh batch of cases pending before the Hon'ble Apex Court.
