
These officials may exercise their option with regard to fixation of pay, if any, as per FR22 within one month from the issue of this order.

However, above named officials are not entitled to the payment of pay & allowances for the period for which they have not actually worked as Grade-II(DSS)/ASO. The benefit of promotion will be admissible to the above mentioned officials only with effect from the actual date of joining to the post of Grade-II(DSS)/ASO in the Department in which they have been posted on promotion to the said post of Grade-II(DSS)/ASO vide this order.

Consequent upon their promotion, the above officials are hereby transferred/posted against vacant posts of Grade-II(DSS)/Assistant Section Officer in the departments as mentioned against their names with immediate effect.

Attention of Head of Department's is also invited to the provisions of DOPT, Govt. of India, OM dated 20/03/1995, stipulating therein to fix responsibility on Controlling Authority for relieving of government servant on his promotion within a period of three months in any case.

Further, in the light of instructions contained in para 5 of DoPT's O.M. No.36012/16/2019-Estt.(Res.) dated 12/04/2022, the promotion order shall be subject to further orders that may be passed by the Hon'ble Supreme Court of India in the Jarnail Singh batch of cases pending before the Hon'ble Apex Court.
