The above mentioned officers may exercise their option, if any, within one month from issue of this order in pursuance of the instructions of Govt. of India regarding fixation of pay as contained in FR-22.

However, above named officials are not entitled to the payment of pay & allowances for the period for which they have not actually worked as Grade-II (DASS). The benefit of promotion will be admissible to the above mentioned officials only with effect from the actual date of joining to the post of Grade-II (DASS) in the Department in which they have been posted on promotion to the post of Grade-II (DASS) vide this order.

The Head of Department concerned should ensure that the aforesaid officials were clear from vigilance angle and no penalty was in operation on the date of his/her notional promotion mentioned against each and no penalty against the official is in operation before relieving above Grade-III (DASS) officials to assume their duties as Grade-II (DASS) as per the instructions contained in DoPT OM No. 22011/4/91-Estt.(A) dated 14/09/1992 and other related OMs.

If any of the officials out of the above, is not clear from vigilance angle or his integrity is not certified as on date of notional promotion/date of issuance of this order or has resigned/ expired/taken VRS etc., the same should be brought to the notice of this department immediately.
