The benefit of promotion will be admissible to the above mentioned officials only with effect from the actual date of joining to the post of Grade-II (DASS) in the Department in which they have been posted on promotion to the post of Grade-II (DASS) vide this order.

The promotion is subject to the condition that Head of the Departments concerned shall ensure that the above mentioned officials are free from Vigilance angle and no penalty against the official is in operation before relieving above Grade-III (DASS) officials to assume their duties as Grade-II (DASS) as per the instructions contained in DoPT OM No. 22011/4/91-Estt.(A) dated 14/09/1992 and other related OMs. It should also be ensured that the above officials are clear from vigilance angle and no penalty was in operation against the official on the date of notional promotion mentioned against each.

If any of the officials out of the above, is not clear from vigilance angle or his integrity is not certified as on date of notional promotion/date of issuance of this order or has resigned/expired/taken VRS etc., the same should be brought to the notice of this department immediately.

Consequent upon their promotion to the post of Grade-II (DASS)/Asstt. Section Officer, the Competent Authority is pleased to order the transfer/posting of the above mentioned officials against the vacant post, of Grade-II (DASS) in departments as mentioned against their names with immediate effect as given below:-
