Departments are also requested to furnish the service particulars as per detailed mentioned, viz., name/DOB, etc. in the attached list only and if there is any change noticed, the same may invariably be brought to the notice of this department.

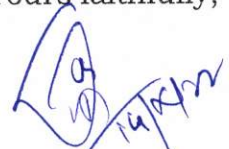
