With reference to the subject cited above, I am directed to forward herewith copy of letter case No.2868/1011/2022/12/2958-2971 dated 25.09.2023 received from the State Commissioner for Persons with Disabilities, addressed to the Chief Secretary, Delhi and copy endorsed to all concerned department, Govt. of NCT of Delhi as well as autonomous and local bodies.

In the instant matter, the State Commissioner for Personal with disabilities had summoned 10 major departments i.e. DoE, DJB, H&FW, MCD, DTC, NDMC, Rehabilitation Services, DSW, I&FC and TTE under Section 82 of Rights of Persons with Disabilities, where the backlog of vacancies are at higher side, for appearance on 13.09.2023 with details of action taken and reasons for delay in forwarding requisitions to DSSSB. After due deliberation and post detailed discussion on 13.09.2023, it was decided that the requisitions to DSSSB/UPSC would be forwarded by all these ten departments latest by 24.09.2023 and the Commission interacted with these departments and after due deliberations, however, the requisite information /action taken/compliance report are still awaited from most of the departments.

Further, in this matter Chief Secretary, Delhi has directed that all concerned departments (List enclosed) will furnish compliance report within a fortnight i.e. latest by **12.10.2023.**

It is, therefore, requested to kindly look into the matter personally and arrange to furnish a compliance report in the matter to the effect that requisitions in respect of all pending backlog vacancies for persons with disabilities have been sent to the concerned board (DSSSB/UPSC) latest by 12.10.2023 positively in the prescribed proforma enclosed herewith through email on monitoringcellservices@ gmail.com as well as through **SPECIAL MESSENGER** so that the matter may be placed before the Chief Secretary, Delhi within the stipulated time for kind perusal.



06.03.2023**

Hon'ble High Court, Delhi vide its judgment dated 6<sup>th</sup> March 2023, in response to the Writ Petition No. WP(C) 8455/2017 & CM Application 34834/2017 filed by National Federation of the Blind against Govt. of NCT of Delhi, directed Chief Secretary, Delhi to fill up the backlog vacancies reserved for Persons with Disabilities in Govt. of NCT of Delhi by not providing reservation in promotion to Disabled Persons.

2. The Hon'ble High Court also mentioned in its judgment that State Commissioner for Persons with Disabilities (SCPD) would monitor the Special Recruitment Drive of GNCTD.

3. In compliance of Hon'ble High Court judgement dated 06.03.2023, undersigned vide D.O. letter dated 22.03.2023 to GNCTD (Chief Secretary) and copy to UPSC, DSSSB and Services Department, requested to adhere to the time frame prescribed by Hon'ble High Court, Delhi for filling up the backlog vacancies and departments were directed to forward requisitions to DSSSB/UPSC within a month i.e. by April 2023 and to complete all procedural formalities to fill up the backlog vacancies under direct recruitment and promotion quota, within 3 months from the date of order of Hon'ble Delhi High Court.

4. In spite of regular follow up by the Services Department, GNCTD and DSSSB for filling up the vacant posts meant for PwDs, desired results have not been achieved so far.

5. A Summon under Section 82 of the RPwD Act, 2016, was issued to ten major defaulting departments i.e. DoE, DJB, H&FW, MCD, DTC, NDMC, Rehab Services, DSW, I&FC and TTE, to appear in the Court of State Commissioner on 13<sup>th</sup> September, 2023, with details of action taken and reasons for delay in forwarding requisition to DSSSB.

6. Post detailed discussions & deliberation on 13<sup>th</sup> Sept., 2023 it was decided that requisitions to DSSSB/UPSC would be forwarded by all these ten deptts. latest by 24.09.2023, with status report to Services Department thereof.

7. To avoid contempt of Hon'ble High Court, these measures were adopted and all these ten major departments were duly explained that it will be sole responsibility of the concerned department in case may adverse stricture by the Hon'ble Court in the subject matter.
