**ORDER NO. 649**

On the recommendations of Screening Committee, the Competent Authority is pleased to order the promotion of the following 232 eligible Grade-II (DASS)/Assistant Section Officer to the post of Grade-I (DASS)/Section Officer in the Pay matrix level-8 of Rs.47600-151100/- (Pre. Revised PB-2: Rs.9300-34800/- plus Grade pay of Rs.4800/-), carrying higher responsibilities, on ad-hoc basis initially for a period of six months or until further orders, whichever is earlier:-

The ad-hoc promotion is subject to the following conditions:-

- i) The ad-hoc promotion is further subject to vigilance clearance in terms of DoPT OM No.22011/4/91-Estt.(A) dated 14.9.92, OM No. 22012/1/99-Estt. (D) dated 25.10.2004 and OM No. 22034/4/2012-Estt.(D) dated 2.11.2012. The relieving of the officer promoted on ad-hoc basis shall be done by the department concerned only after ensuring that no disciplinary proceedings are pending or contemplated against the officer. In case of pendency of such proceedings, the matter may be reported to this Department immediately.
- ii) The promotion on ad-hoc basis will be effective from the date of assumption of charge of the post of Grade-I (DASS), having higher responsibilities, in the Department to which he/she will be posted by a separate order.
- iii) The ad-hoc promotion to the post of Section Officer shall not bestow on the incumbents any claim for regular promotion to the grade.
- iv) The promotion is being made purely on ad-hoc basis and the ad-hoc promotion will not confer any right for regular promotion.
- v) The service rendered on ad-hoc basis as Grade-I (DASS)/Section Officer would not count for the purpose of seniority in that grade or for promotion to the next higher grade.
- vi) The ad-hoc promotion shall not confer any right on the incumbents to continue in the grade indefinitely and may be terminated at any point of time without giving any reasons thereof.
- vii) This promotion shall be initially for six months or "until further order", whichever is earlier. The Government reserves the right to



- cancel at any time the ad-hoc promotion and revert the government servant to the post from which he/she was promoted.
- viii) The ad-hoc promotion is further subject to outcome of the SLP (C) No.6915/2014 & SLP (C) No. 031288/2017 and other connected cases before the Hon'ble Supreme Court.
- ix) The promotions will be subject to any further clarification that may be received from DoPT in future on the matter related to "Reservation in Promotion".

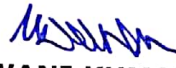
