The above promoted officials may exercise their option, if any, within one month in pursuance of the instructions of Government of India regarding fixation of pay as contained in FR-22.

Further, above promotion is subject to outcome of O.A. No.1660/2012 filed by APOs before the Hon'ble CAT.

However, the above officials are not entitled to the pay & allowances for the period for which they have not actually worked as Grade-I(DASS). They will avail the benefit of promotion on joining duty in the department in which they have been posted on promotion to the post of Grade-I (DASS).

Consequent upon their promotion to the post of Grade-I(DASS), all the above-mentioned GP officials are posted as Superintendent in Directorate of Education, against the vacant posts.

The Head of Departments concerned should ensure that above-mentioned officials are clear from vigilance angle, before relieving them to take up their new assignment. If any of the officials out of the above is not clear from vigilance angle or has resigned/relieved/expired etc., the same should be brought to the notice of this department immediately.
