**ORDER No. 246**

In supersession of this departments' order No. 45 dated 05.02.2007 in respect of Shri Udai Veer Singh(DOB:08.09.1959)(Sl.No.1), and in pursuance of the order dated 28.11.2012 of the Hon'ble Lt. Governor, Delhi, thereby exonerating Shri Udai Veer Singh, the then Grade-II(DASS), Seniority No. 5033 of the charges leveled against him by the Disciplinary Authority vide order dated 25.02.2005 and on the basis of findings of the Departmental Promotion Committee, kept in the sealed cover in the meeting of DPC held on 01.08.2002, the Chief Secretary, Delhi, is pleased to order the appointment of Shri Udai Veer Singh, the then Grade-II(DASS), Seniority No. 5033, under rule 6 of DASS Rules 1967, to the post of Grade-I (DASS) in the pay scale of ₹6500-10500 (pre-revised), with effect from 07.07.2003 (notionally) on regular basis i.e. the date from which his junior Shri Lokesh Kumar Rastogi, Grade-II (DASS), Snty.No.5038 was promoted to the post of Grade-I (DASS).

He may exercise option, if any, within one month in pursuance of the instructions of Government of India regarding fixation of pay as contained in FR.22.

However, he is not entitled to the payment of pay & allowances for the period for which he has not actually worked as Grade-I (DASS). The benefits will be admissible with effect from the actual date of his joining to the post of Grade-I (DASS).
