ORDER NO. 150

On the recommendations of the Departmental Promotion Committee, Ms. Rita Dua, Grade-IV (DASS) (DOB: 04/08/55, Seniority No.7230), presently posted in EDN, is hereby promoted to the post of Grade-III (DASS), on regular basis, in the pay scale of Rs 4000-100-6000 (Pre-Revised) under Rule 6 of the DASS Rules 1967, effective notionally from 27/06/2003.
