The aforesaid ad-hoc promotion of the officials is subject to the following conditions: -

- I. The ad-hoc promotion is further subject to vigilance clearance in terms of DOPT OM No. 22011/4/91-Estt.(A) dated 14.9.92, OM No. 22012/1/99-Estt.(D) dated 25.10.2004 and OM No. 22034/4/2012-Estt.(D) dated 2.11.2012. The Department where the officials is working should relieve the official only after verifying that no disciplinary proceedings are pending or contemplated against the official. In case of pendency of such proceedings, the matter may be reported to this Department immediately.
- II. The promotion on ad-hoc basis is effective from the date of assumption of charge of the post of Private Secretary Grade by the officials in the Department to which he/she has been posted.
- III. The ad-hoc promotion of Private Secretary Grade of Stenographers Cadre shall not bestow on the incumbents any claim for regular promotion to the grade.
- IV. The promotion is being made on purely on ad-hoc basis and the ad-hoc promotion will not confer any right for regular promotion.
- V. The service rendered on ad-hoc basis in the Private Secretary Grade would not count for the purpose of seniority in that grade or for promotion to the next higher grade.
- VI. The ad-hoc promotion shall not confer any right on the incumbents to continue in the grade indefinitely and may be terminated at any point of time without giving any reasons thereof.
- VII. This promotion shall be initially for a period of six months or "until further order" whichever is earlier, the Government reserve the right to cancel at any time the ad-hoc promotion and revert the government servant to the post from which he/she was promoted.
- VIII. The ad-hoc promotion will remain subject to outcome of the SLP (C) No. 6915/2014 & SLP (C)No. 031288/2017 and other connected cases before the Hon'ble Supreme Court:
