

Dear Sir/Malan,

I would like to draw your attention towards amendment carried out in the IAS (Pay) Rules, 2016 vide Notification dated 30.12.2021 which inter-alia made it mandatory for officers to file IPR for being considered for appointment in the next level of pay in the pay matrix. Further, as mandated by the amended provisions, instructions were issued by this Department vide letter dated 28.06.2022 to all the State cadres conveying that as a one-time measure, the online SPARROW Portal would remain open w.e.f. 15.07.2022 to 14.09.2022 to enable the officers to file their missing IPR, if any, from 01.01.2011 onwards.

- 2. It has now been learnt that some officers have not filed their missing IPRs even after having been granted ample opportunity vide instructions dated 28.06.2022. This might impact future career progression of such officers and may, therefore, also lead to a large number of representations at a later stage.
- 3. In this context, the Central Government has taken a considered view to grant one last opportunity to IAS officers to file their missing IPRs. Accordingly, the window will remain open on SPARROW portal for a period of one month from 15.06.2023 to 14.07.2023.
- 4. I seek your personal intervention for widely circulating this opportunity among officers with a special stress on timelines and future implications of non-filing of IPRs.
