**Subject: Timely implementation of Unified Pension Scheme (UPS) for All India Services (AIS) Officers**

1. This is with reference to our letters dated 02.02.2026 and 21.11.2025 on the above mentioned subject. Further, reference is also invited to letters dt 30 April 2025 and 26 September 2025 issued by Department of Personnel & Training, Ministry of Personnel, Public Grievances & Pensions, Government of India and letter dt 16 May 2025 sent by PFRDA to all the Chief Secretaries of the State Governments and Union Territories on the captioned subject matter.

2. It is pertinent to mention that the cut-off date to opt for UPS by AIS subscribers was 30.11.2025 and considerable time period has lapsed since the enabling of system and closure of last date to opt for UPS. The UPS migration activity is a time bound exercise, it is therefore advised to complete the same latest by 30 April 2026 including the following activities:

(a) Providing details to PCRA for creation of SNO without further delay. In absence of creation of SNO, mapping and migration of PRANs of AIS officials cannot be undertaken.

(b) Providing details of all AIS officials posted in the state/ UT to PCRA for completing mapping to the SNO created specifically for AIS officials.

(c) Providing details of physical migration forms pending with the nodal offices, to PCRA at the earliest.

(d) Initiating and authorizing the migration in CRA system for AIS officials who have opted for UPS.

|| It is reiterated that post 30.04.2026, the functionality for migration to UPS for AIS subscribers, will be disabled. ||

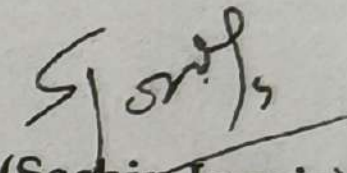
