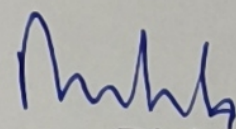
Subject: Exercise of Split Option under Saving Clause of FR-22(I)(a)(1) by Grade-I (DSS) officers appointed on ad-hoc basis to Ex-Cadre posts in Govt. of NCT of Delhi.

The Services Department has received representation(s) from certain Grade-I (DSS) officers, appointed on ad-hoc basis to Ex-Cadre posts in Govt. of NCT of Delhi, for extending the benefit to exercise split option under Saving Clause of FR-22(I)(a)(1), in terms of DoPT O.M. F. No.4/8/2016-CS-I(D)(Part-I) dated 27.08.2020, as juniors were drawing more pay than their seniors due to different joining dates.

2. In order to resolve the afore-stated anomalous situation, the matter was examined in this Department in consultation with Expenditure-I Division of Finance Department, Govt. of NCT of Delhi considering Rule 3 of the GNCTD (Conditions of Service of Officers and Other Employees Service) Rules, 2025 issued by Ministry of Home Affairs, Govt. of India's Gazette Notification G.S.R. 453(E) dated 07.07.2025. Accordingly, the Hon'ble Lt. Governor has accorded his approval to extend the benefit of DoPT O.M. F. No.4/8/2016-CS-I(D)(Part-I) dated 27.08.2020 to those affected Grade-I (DSS) officers who were promoted/appointed on ad-hoc basis to ex-cadre posts in Govt. of NCT of Delhi prior to the date of increment & drawing salary less than their juniors due to different joining dates.

3. All the Departments under Govt. of NCT of Delhi may process all such requests of Grade-I (DSS) officers appointed on ad-hoc basis to Ex-Cadre posts in Govt. of NCT of Delhi, on a case-to-case basis, so as to ensure that conditions as laid in the said DoPT O.M. dated 27.08.2020 is strictly complied and no undue benefit is accrued to the applicants.

4. This issues with the prior approval of the Hon'ble Lt. Governor.
