Sub: Appointment on compassionate grounds-determination of vacancies

Sir / Madam,

This is in reference to this office letter of even number dated 12/04/2024, dated 08/08/2024 and dated 28/08/2024 vide which vacancies reserved for compassionate appointment falling under direct recruitment quota for the period ending 31-03-2024 and period ending 30-06-2024 respectively were sought in a prescribed proforma (enclosed therewith) from various departments of GNCTD of Delhi.

In response to the above, various departments of GNCT of Delhi have submitted their vacancies report and upon perusal of these reports, it has been observed that some of the departments have not provided the vacancies status for appointment on compassionate ground according to the instruction laid down in para 7(b) of Master Circular issued by GOI vide DoPT's letter No. F. 14014/1/2022-Estt.(D) dated 02.08.2022 which stipulates that "Compassionate appointments can be made upto a maximum of 5% of vacancies falling under direct recruitment quota in any Group 'C' post. The appointing authority may hold back upto 5% of vacancies in the aforesaid categories to be filled by direct recruitment through Staff Selection Commission or otherwise so as to fill such vacancies by appointment on compassionate grounds".

The above instruction of DoPT's may be understood with the help of an illustration. Supposed department 'A' has 500 sanctioned posts of Group 'C' including the post of MTS (erstwhile Group-D) and in a current year 100 vacant posts of Group 'C' including the post of MTS (erstwhile Group-D) arose in the department under direct recruitment quota due to the retirement/voluntary retirement/death/promotion of the employees. Hence, according to the above policy, 5% of vacancies to be hold back for compassionate appointment in the department will be equal to 5 posts i.e., 5% of 100 vacant posts arose for Direct Recruitment Quota in a particular year.

Accordingly, the departments may calculate and provide the vacancies that arose after the vacancies were last reported to Services Department. The departments may further ensure that the vacancies already furnished to Services Department are not forwarded again so that the limit of 5% reservation meant for compassionate appointment is not exceeded.

Keeping in view of the above, all the departments of GNCT of Delhi are requested once again to provide the updated status of vacancies as on 31-12-2024 i. e. 5% of the vacancies to be hold back for compassionate appointment under direct recruitment quota of Group 'C' including MTS (erstwhile Group-D) arose in the department and to be filled through DSSSB or otherwise by **15-02-2025**.
