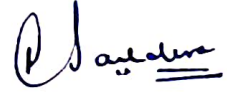

The Head of Departments concerned should ensure that no disciplinary/criminal proceedings are pending or any penalty is in operation against any of the above mentioned officials, before relieving them to take up their new assignment on promotion. If any officials, out of the above, is not clear from vigilance angle or has resigned/relieved/expired etc., the same should be brought to the notice of this department immediately.

8. This issues with the approval of the Competent Authority.



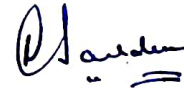
