Madam/Sir,

I am directed to inform you that this Department is initiating process to fill up the vacant posts of Grade-II (GNCTDSS) from Grade-III (GNCTDSS) officials under UR category having **Snty. No. from 10739 to 10957** & who will be completing eight years of qualifying service on 31/12/2024 as per new service rules, i.e, GNCTDSS Rules, 2022 that requires minimum 08 years of qualifying service. The list of Grade-III (GNCTDSS) officials, as per **Annexure 'A'**, is being enclosed with the request that the Integrity Certificate & Vigilance Clearance Report (as per **Annexure 'C'**), Proforma as **Annexure 'D'** and Annual Performance Assessment Reports for the last five years (from 2017-18 to 2021-22) in respect of the officials presently posted in your department, after verifying the details from their service records, may be made available to this department.

A separate list of the Grade-III(GNCTDSS)/Kanungo/Adhoc Grade-II(GNCTDSS) officials in **Annexure 'B'** whose cases were deferred/placed in sealed cover by the earlier DPC/Screening Committee is also enclosed with the request that the requisite service particulars in respect of these officials, presently posted in your department, may also be made available to this department.

The requisite information **strictly in the prescribed proforma as per Annexure 'C' & 'D'** in respect of the officials mentioned in **Annexure 'A' & 'B'** may be made available at the earliest to facilitate assessment of their suitability for promotion to the post of Grade-II (GNCTDSS). In case of left out cases of previous DPCs, vigilance clearance/no penalty certificate for promotion as on date of notional promotion as per **Annexure 'E'** may also be provided in addition to **Annexure 'C' & 'D'**.

The requisite APARs in respect of the officials mentioned in the **Annexure 'A' & 'B'** be made available to the Deputy Secretary (Services), Services-IV Branch, Services Department, 5<sup>th</sup> Level, B-Wing, Delhi Secretariat, New Delhi. In case the requisite APARs have not been written, a non-reporting certificate / non-availability certificate along-with all the available APARs may kindly be sent to this department. Further, IC/VC (**Annexure 'C'**), Proforma (**Annexure 'D'**) & Vigilance Clearance/No Penalty Certificate (**Annexure 'E'**) may be made available to Deputy Secretary (Services), Services-II Branch.

It is also requested that **all the HOD(s) concerned shall provide Vigilance Clearance strictly in accordance with OM No. 22034/4/2012-Estt.(D) dated 02/11/2012 issued by DoPT, GoI & strictly as per Annexure 'C' in respect of the officials being considered for promotion.**




