Sub:- Re-assignment of seniority in the seniority list of Grade-II(DSS)/Asstt. Section Officer

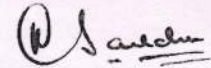
Sir,

This is issued with the approval of the Competent Authority. The officials may please be informed accordingly.



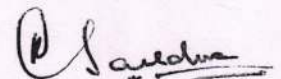
