On the recommendation of the review DPC conveyed, the Competent Authority is pleased to appoint the following Grade-II (DSS) officials on promotion on regular basis to the post of Grade-I (DSS) (Group-B Gazetted) under rule 7 of GNCDTSS Rules, 2022 in the pay scale level 8: Rs.47600-151100/- (as per 7th CPC), notionally with effect from the date mentioned against their names at column No. VII and actually with effect from the date of assumption of duties of Grade-I (DSS), as per details given below:-

The above named promoted officials may exercise option, if any, within one month in pursuance of the instructions of Government of India regarding fixation of pay as contained in FR-22.

However, above named officers are not entitled to the payment of pay & allowances for the period for which they have not actually worked as Grade-I (DSS). The benefits will be admissible with effect from the actual date of their joining to the post of Grade-I (DSS). They will avail benefits of promotion on their joining of duty in the department in which they have been posted on promotion to the post of Grade-I (DSS).

Further, the promotion is subject to the condition that the Head of the Departments concerned must ensure that no disciplinary proceedings/criminal proceedings were pending or no penalty was in operation against the promotee officials on the date of their notional promotion before relieving them to take up their new assignment on promotion in the light of instructions contained in DoPT OM No. 22011/4/91-Estt(A) dated 14.09.1992 and other related OMs issued from time to time. The above said conditions related to vigilance clearance & status of penalty shall invariably be mentioned in their relieving order as well.

If any of the officials out of the above, is not clear from vigilance angle or his

integrity is not certified as on date of their notional promotion or has resigned/expired/taken VRS etc., the same should be brought to the notice of this department immediately.

Further, consequent upon their promotion to the post of Grade-I (DSS), the Competent Authority is pleased to order transfer/posting of the following officers against the vacant posts of Grade-I (DSS)/Section Officer in departments as mentioned against their names:-
