However, above named officials are not entitled to the payment of pay & allowances for the period for which they have not actually worked as Grade-II(DSS)/ASO. The benefit of promotion will be admissible to the above mentioned officials only with effect from the actual date of joining to the post of Grade-II(DSS)/ASO in the Department in which they have been posted on promotion to the said post of Grade-II(DSS)/ASO vide this order.

officials on the date of their notional promotion before relieving them to take up their new assignment on promotion in the light of instructions contained in DoPT O.M. No.22011/4/91-Estt(A) dated 14/09/1992 and other related OMs issued from time to time. The above said conditions related to vigilance clearance & status of penalty shall invariably be mentioned in their relieving order as well. Further, an undertaking in this regard shall also be obtained from the officials concerned by the administrative department concerned before relieving to their new assignment on promotion.

If any of the officials out of the above, is not clear from vigilance angle or his integrity is not certified as on date or has resigned/ expired/taken VRS etc., the same should be brought to the notice of this department immediately.

Attention of Head of Department's is also invited to the provisions of DOPT, Govt. of India, OM dated 20/03/1995, stipulating therein to fix responsibility on Controlling Authority for relieving of government servant on his promotion within a period of three months in any case.

Further, in the light of instructions contained in para 5 of DoPT's O.M. No.36012/16/2019-Estt.(Res.) dated 12/04/2022, the promotion order shall be subject to further orders that may be passed by the Hon'ble Supreme Court of India in the Jarnail Singh batch of cases pending before the Hon'ble Apex Court.
