The official may exercise her option with regard to fixation of pay, if any, as per FR22 within one month from the issue of this order.

However, above named official is not entitled to the payment of pay & allowances for the period for which she has not actually worked as Grade-III(GNCTDSS)/Sr. Assistant. The benefit of promotion will be admissible to the above mentioned official only with effect from the actual date of joining to the post of Grade-III(GNCTDSS)/Sr. Assistant in the Department in which she has been posted on promotion to the post of Grade-III(GNCTDSS)/Sr. Assistant vide this order.

Consequent upon her promotion, the aforesaid official is hereby transferred/posted against vacant posts of Grade-III(GNCTDSS)/Sr. Assistant in the department as mentioned against her name with immediate effect.

The promotion is subject to the condition that the Head of the Department concerned must ensure that no disciplinary proceedings/criminal proceedings was pending or no penalty was in operation against the promotee official on the date of her notional promotion i.e. 23/10/12 before relieving her to take up her new assignment on promotion in the light of instructions contained in DoPT O.M. No.22011/4/91-Estt(A) dated 14/09/1992 and other related OMs issued from time to time. The above said conditions related to vigilance clearance & status of penalty shall invariably be mentioned in her relieving order as well. Further, an undertaking in this regard shall also be obtained from the official concerned by the administrative department concerned before relieving to her new assignment on promotion.

If the official is not clear from vigilance angle or her integrity is not certified as on date or has resigned/ expired/taken VRS etc., the same should be brought to the notice of this department immediately.

Attention of Head of Department's is also invited to the provisions of DOPT, Govt. of India, OM dated 20/03/1995, stipulating therein to fix responsibility on Controlling Authority for relieving of government servant on his promotion within a period of three months in any case.

Further, In the light of instructions contained in para 5 of DoPT's O.M. No.36012/16/2019-Estt.(Res.) dated 12/04/2022, the promotion order shall be subject to further orders that may be passed by the Hon'ble Supreme Court of India in the Jarnail Singh batch of cases pending before the Hon'ble Apex Court.
