Further, if no post of Grade-I (DSS) is lying vacant in the department concerned, the concerned Grade-I (DSS) officer(s) on promotion will be posted in Directorate of Education (in diverted capacity for pay purpose only) and continue to work in their present place of posting till further orders.

The benefit of promotion will be admissible to the aforementioned officers only with effect from the actual date of joining to the post of Grade-I (DSS) in the Department in which they have been posted on promotion to the post of Grade-I (DSS).

The promotion shall be subject to outcome of further orders that may be passed by the Hon'ble Supreme Court in the case of Jarnail Singh & Others (Civil Appeal No. 629 of 2022) arising out of SLP(C) No.30621/2011 as conveyed by the DoPT vide OM no. 36012/16/2019-Estt.(RES) dated 12.04.2022.
