ORDER NO. 59

On the recommendations of the Review Departmental Promotion Committee, the Competent Authority is pleased to appoint Sh. Virender Kumar (DOB: 21.08.1984), Grade-III(DSS)/Senior Assistant having seniority No. U10830 Category UR, on promotion to the post of Grade-II (DSS)/Assistant Section Officer in level 07 of pay matrix of pay scale of Rs. 44900-142400 (pre-revised Rs. 9300-34800 with grade pay Rs. 4600/-) notionally w.e.f 01/01/2025 under Rule 7 of the Govt. of NCT of DSS Rules, 2022.

The official may exercise option with regard to fixation of pay, if any, as per FR22 within one month from the issue of this order.

However, the financial benefits will be admissible to the above mentioned official with effect from the actual date of joining to the post of Grade-II/ASO and no arrear will be allowed for the period he has not actually worked as Grade-II/ASO.

Further, consequent upon his promotion to the post of Grade-II (DSS)/Assistant Section Officer, the above official will continue to work in his present department, i.e., Chief Minister Office (Diverted from CEO), against vacant post of Grade-II(DSS)/Assistant Section Officer.

The promotion is subject to the condition that the Head of the Department concerned must ensure that no disciplinary proceeding/criminal proceeding is pending or no penalty was in operation against the promotee official on the date of his notional promotion before relieving him to take up new assignment on promotion in the light of instructions contained in DoPT O.M. No.22011/4/91-Estt. (A) dated 14/09/1992 and other related OMs issued from time to time. The above said conditions related to vigilance clearance & status of penalty shall invariably be mentioned in his relieving order as well. Further, an undertaking in this regard shall also be obtained from the official concerned by the administrative department concerned before relieving him to new assignment on promotion.

If above official is not clear from vigilance angle or his integrity is not certified as on date of notional promotion, the same should be brought to the notice of this department immediately.

Attention of Head of Department is also invited to the provisions of DOPT, Govt. of India, OM dated 20/03/1995, stipulating therein to fix responsibility on Controlling Authority for relieving of government servant on his/ her promotion within a period of three months in any case.

The promotion shall be subject to outcome of further orders that may be passed by the Hon'ble Supreme Court of India in the case of Jarnail Singh & Others (Civil Appeal No.629 of 2022) arising out of SLP (C) No.30621/2011, as conveyed by the DoPT vide OM No.36012/16/2019-Estt.(RES) dated 12/04/2022.
