Further, the promotion is subject to the condition that the Head of the Departments concerned must ensure that no disciplinary proceedings/criminal proceedings were pending or no penalty was in operation against the promotee officials on the date of their notional promotion before relieving them to take up their new assignment on promotion in the light of instructions contained in DoPT OM No. 22011/4/91-Estt(A) dated 14.09.1992 and other related OMs issued from time to time. The above said conditions related to vigilance clearance & status of penalty shall invariably be mentioned in their relieving order as well.

However, above named officials are not entitled to the payment of pay & allowances for the period for which they have not actually worked as Grade-I (DSS). The benefit of promotion will be admissible to the aforementioned officers only with effect from the actual date of joining to the post of Grade-I (DSS) in the

Department in which they have been posted on promotion to the post of Grade-I (DSS).

If any of the officials out of the above, is not clear from vigilance angle or his integrity is not certified as on date of their notional promotion or has resigned /expired / taken VRS etc., the same should be brought to the notice of this department immediately.

The promotion shall be subject to outcome of further orders that may be passed by the Hon'ble Supreme Court in the case of Jarnail Singh & Others (Civil Appeal No. 629 of 2022) arising out of SLP(C) No.30621/2011 as conveyed by the DoPT vide OM no. 36012/16/2019-Estt.(RES) dated 12.04.2022.
