## Sub: Preparation of panel for promotion of Grade-III (GNCTDSS) officials appointed on promotion on 01/01/2017 under UR category & promotion of Left Out Cases of previous DPCs to the post of Grade-II (GNCTDSS) on regular basis – regarding.

Madam/Sir,

Kindly refer to this department's letter of even number dated 23/07/2024 wherein it was intimated that this Department is considering the cases of Grade-III(GNCTDSS) under UR category having **Snty. No. from 10739 to 10957** for their promotion to the post of Grade-II (GNCTDSS) on regular basis and it was requested to send the information i.e. Integrity Certificate & Vigilance Clearance Report (as per **Annexure 'C'**), Proforma as **Annexure 'D'** and Annual Performance Assessment Reports for the last five years (from 2017-18 to 2021-22) in respect of eligible Grade-III (GNCTDSS) officials presently posted in your department, after verifying the details from their service records.

If required, department concerned may consult Directorate of Vigilance, GNCTD for issue of vigilance clearance. Departments are also requested to furnish the service particulars as per detailed mentioned, viz., name/DOB, etc. in the attached list only and if there is any change noticed, the same may invariably be brought to the notice of this department. It may be noted that only those officials will be considered whose record is made available and in case any official does not get considered due to non-furnishing of requisite documents/papers/information by the concerned Department, the responsibility shall solely rest with the concerned Department.

The contents of this circular may be brought to the notice of the officials concerned.
