ORDER NO. 1

In pursuance of directions of Hon'ble CAT dated 28.05.2015 in the matter of MA No.2494/2014 & MA No.2495/2014 in OA No.1548/2003 in the matter of Sunil Kumar & Ors Vs. Govt. of NCT of Delhi and Ors. regarding grant of the financial upgradation to the Gr.IV(DASS)/LDC officials after counting of their past service rendered in the DEDA(an autonomous body) and accordingly the recommendations of the Screening Committee constituted for grant of financial upgradation under the Assured Career Progression Scheme to Gr.IV(DASS) officials in accordance with the instructions contained in O.M. No. 35034/1/97 Estt.(D) dated 09.08.99 of the Govt. Of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Pr. Secretary (Services) is pleased to grant 1st financial up gradation under ACP Scheme on completion of 12 years regular service in respect of the following 02 Gr.IV(DASS)/ LDC officials in the next higher pay scale of Rs.4000-6000 (pre revised) w.e.f. the date mentioned against their names :-

However, the grant of higher pay scale is subject to the undertaking that in the event of overpayment, which may be detected at a later stage, the same will be recovered from their pay.

The official concerned may be allowed to exercise their option, if any, under FR 22 within one month of the issuance of the order granting the financial up-gradation under the Assured Career progression Scheme.

The concerned Heads of Departments are requested to ensure before issuing final order that official is clear from vigilance angle.

In case of employees declared surplus and redeployed in Delhi Govt., HODs may ensure before issue of final orders that concerned official's have not been given any financial upgradation/promotion and completed at least 12 years of regular service for 1st financial upgradation during his tenure including service prior to redeployment in Govt. of NCT of Delhi.

The concerned Head of Departments/Head of Offices is requested to issue formal orders for grant of the financial upgradation in respect of the officials working in their departments. However, before the issuance of the final orders the Head of Department may again confirm that the official's have not been given any promotion since the date of initial appointment in their service and completed at least 12 years of regular service on the date of granting financial upgradation without promotion.
