ORDER 03

On the recommendations of the Screening Committee constituted for grant of financial upgradation under the Modified Assured Career Progression Scheme to Stenographers Gr.II officials in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. Of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. Of Personnel & Training), the Pr. Secretary (Services) is pleased to grant 2nd financial upgradation to the following Stenographers Gr.II officials, on completion of 20 years of regular service with one promotion from the corresponding Pay Band – II of Rs. 9300-34800/- Grade Pay 4600/- to the immediate next higher Grade Pay of Rs.4800/- in the hierarchy of the recommended revised pay bands w.e.f. the dates mentioned against their names:-

Services Department vide Order No.57 dated 03.02.2015 revised the pay structure of Gr.II (DASS) and Stenographer Gr.II in PB-2 Rs.9300-34800 from Grade Pay of Rs.4200/- to Rs.4600/- w.e.f. 01.01.2006.

The officials concerned may be allowed to exercise their option, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The Head of Departments concerned is requested to ensure before issuing final order that 20 years of regular service of the official does not include the period of service rendered in State Government /Statutory Body/ Autonomous Body/ Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial upgradation under MACP Scheme (Point No.10 of DoPT OM dated 19.05.09).

The concerned Head of Departments are requested to issue formal order for grant of the 2nd financial upgradation in respect of the above mentioned officials working in their Departments. However, before the issuance of the formal orders the Head of Departments may again confirm that these officials have completed 20 years of regular service with one promotion since the date of their initial appointment in the service and are **clear from Vigilance angle**.

The department of the official as mentioned against their name may vary due to transfer/joining of the official concerned during the period.

The officials who are on deputation will get financial upgradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to the Delhi Government.
