I am directed to say that it is proposed to fill up four (04) posts of Assistant Director (Disaster Management) in Level-10 in the Pay Matrix in Disaster Management Division of Ministry of Home Affairs on Deputation (including short-term contract) basis. The particulars of the post, eligibility conditions etc. are given in Annexure-I.

2. The pay of the selected efficer will be regulated in accordance with the Department of Personnel & Training O.M. No. 6/8/2009-Estt. (Pay II) dated 17.06.2010 as amended from time to time.

The maximum age limit for appointment on deputation (including short-term contract) shall be 56 years. Accordingly, the persons who will be crossing the age of 56 years, on the last date of receiving of applications as indicated in para-4 need not apply.

- 4. (x) International cooperation including bilateral agreement in the field of emergency response.
 (xi) Organization of national events viz. conferences, seminars, meetings etc. including

international events in the country relating to disaster management.

(xii) Analytical processing of various proposals on various aspects of disaster preparedness and mitigation received from various agencies.

(xiii) All other matters relating to response to disaster situation and early warning.

(xiv) To work as a resource person in the National Institute for Disaster Management and Faculty on NDM in State ATIs.

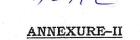
