I am directed to say that one post of Senior Instructor (Fishing Technology) in Level 10 of the Pay Matrix ( ie. in the pre-revised pay band -3 Rs.15600-39100 with Grade pay of Rs.5400/-) (Group "A" Gazetted, Non-Ministerial) in Central Institute of Fisheries Nautical and Engineering Training Unit, Chennai is proposed to be filled up on deputation (including short term contract) basis from amongst the Officers of the Central Government or State Government or Union Territories or Universities or recognized Research Institutions or Public Sector undertaking or Semi Government or Autonomous Bodies or Statutory Organisations:-

- (a) (i) holding analogous post on regular basis in the parent cadre or Department; or
- (ii) with two years service in the grade rendered after appointment thereto on regular basis in pay band-2 of Rs.9300-34800 with Grade Pay of Rs.4800 or equivalent in the parent Cadre or Department; or
- (iii) With three years service in the grade rendered after appointment thereto on regular basis in Pay Band-2 of Rs.9300-34800 with Grade Pay of Rs.4600 or equivalent in the parent Cadre or Department; and
- iv) with eight years service in the grade rendered after appointment thereto on regular basis in pay band-2 of Rs.9300-34800 with grade pay of Rs.4200 or equivalent in the parent cadre or department ; and
- (b) possessing the following educational qualifications and experience:



## Essential:

- (i) Master's Degree in Zoology or Fishery Science or Industrial Fisheries from a recognized University ;

Or

Post Graduate Diploma in Fishery Science from Central Institute of Fishery Education, Mumbai.

- (ii) Three years experience in Marine Fisheries, Fishing Gear Design, Fabrication and material selection; or
- (i) Bachelor of Fishery Science (Nautical Science) from a recognized university;
- (ii) Five Years' experience in Marine Fisheries, Fishing Gear Design, Fabrication and material selection.

Note 1: Qualifications are relaxable at the discretion of the Union Public Service Commission for reasons to be recorded in writing in case of candidates otherwise well qualified.

Note 2: The qualification regarding experience is relaxable at the discretion of the Union Public Service Commission for reasons to be recorded in writing, in the case of candidates belonging to the Scheduled Castes or the Scheduled Tribes, if at any stage of selection, the Union Public Service Commission is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.

The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

[Period of deputation (including short term contract) including period of deputation(including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation(including short term contract) shall be not exceeding 56 years as on the closing date of receipt of applications].

Note: ∴ For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1<sup>st</sup> January, 2006(date from which the revised pay structure based on, the Sixth Central Pay Commission recommendation has been extended) shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the said Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post for which that grade pay or pay scale is the normal replacement grade without any up-gradation.


**Job description:** Engaging class in fishing gear technology and fish capture techniques both theoretical and practical to trainees and assisting the Chief Instructor (FT) in the functioning of craft and gear division. Undertake fishing cruise as shore officer participant alongwith institutional/post-institutional trainees on board the fishing vessel for imparting practical training. Any other duties assigned by the superiors.

The initial place of posting will be at CIFNET Unit, Chennai.

2. The pay of the official selected will be governed by the provisions laid down in the Department of Personnel and Training's O.M.No.6/8/2009-Estt(pay II) dated 17<sup>th</sup> June 2010 as amended from time to time.


