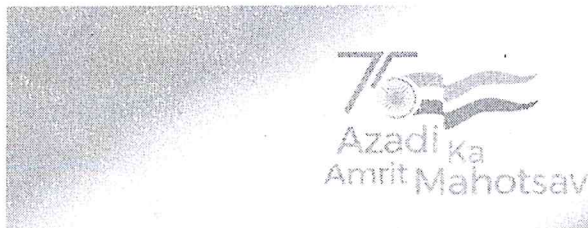

Annexure

The knowledge and skill set requiring special expertise are broadly the following.

- (a) Association with security at various levels, including dealing with security gadgets. Knowledge of latest security technology such as in the areas of CCTV, anti-intrusion electronic surveillance cum alarm systems, access control related RFID technology, sensor based access control measures, variety of technology to check and scan bags and vehicles without opening it, perimeter security related hardware, AI and its usage for perimeter security and access control and ballistic and blast proof security material including BR/BP vehicles.
- (b) Knowledge of framing 'scope of work' pertaining to procurement and installation of above mentioned technology solutions.
- (c) Knowledge and skill of testing technology solutions during and after procurement by crosschecking it against technical specifications and BOQ decided in the tender/competitive bidding documents. Also skill and experience in vetting security clauses in a variety of service agreements entered into by our Missions/Posts.
- (d) Skills in interview and interrogation, skills in liaison with various agencies.
- (e) Knowledge of procurement procedures as per GFR.
