1. COMPANY PROFILE

The Damodar Valley Corporation (DVC) is a Statutory Body established under the Damodar Valley Corporation Act, 1948. It is a major power utility in the Eastern Region of the country, playing a key role in the unified development of the Damodar Valley basin in the States of West Bengal and Jharkhand. Main functions of DVC are generation, transmission and distribution of electricity. Its subsidiary activities are flood control, irrigation, soil conservation & afforestation, industrial, economic and other development of Damodar Valley area. DVC provides power supply to the core sector industries like coal, steel and railway in its command area. The present employee strength of the Corporation is around 7,000 belonging to various disciplines. DVC has a total capacity of 6691 MW consisting of six Thermal Power Stations (6540 MW), three hydel power stations (147.2 MW) and 3.92 MWp Roof-top & Floating Solar Power in Valley area.

The primary stakeholders of the Corporation are (i) the Central Government, (ii) the Government of Jharkhand and (iii) the Government of West Bengal. The capital fund of the Corporation as on 31.03.2022 is Rs. 5196.20 crore (Central Government: Rs. 1820.67 crore, Government of West Bengal: Rs. 1593.98 crore and Government of Jharkhand: Rs. 1781.55 crore.). The Headquarters of DVC are located at Kolkata, West Bengal.

2. JOB DESCRIPTION AND RESPONSIBILITIES

Chairman shall be the Chief Executive Officer and Head of the Corporation and accountable to its Board of Directors and Government. Chairman will be primarily responsible for conceptual thinking, policy formulation and issuing directions in relation to its multi-pronged activities. Detailed functions of the Chairman entail long range planning, organizing, coordination and control over the administrative activities of the various Departments (including Thermal Power Stations and Dams) to ensure optimal achievement of the objectives of Damodar Valley Corporation. He will be responsible for the efficient functioning of the Corporation for achieving its corporate objectives and performance parameters.
