It has been decided to fill up vacancies in the Protectorate of Emigrants offices located in the following cities on deputation basis:

2. The vacancies to be filled up in the PoE offices are in the grades of Deputy Secretary/Under Secretary (minimum pay level-11), Section Officer (minimum pay level-08) and Assistant Section Officers (pay level-07). The details of the vacancies are attached as Annex - A.

3. The tenure in the PoE offices will be for a minimum period of **two years** on deputation basis, which can be further extended as per rules.


4. The Protectors of Emigrants perform functions as assigned to them under the Emigration Act, 1983, which inter alia include:

- To protect, and advice all intending emigrants.
- Oversee all the provisions of the Emigration Act, 1983 and compliance of rules made there-under.
- Granting emigration clearance to the intending emigrants as per the procedure prescribed under the Emigration Act, 1983.
- Monitoring recruitment activities of RAs, illegal agents under the supervision of the Protector General of Emigrants
- Inspect, to an extent and in a manner as may be prescribed, any emigrant conveyance, or any other conveyance if he has reason to believe that any intending emigrant or emigrants are proceeding from, or returning to, India; to or from a place outside India by such other conveyance.
- Inquire into the treatment received by emigrants during their voyage or journey to, and during the period of their residence in the country to which they emigrated and also during the return voyage or journey to India and report thereon to the Protector General of Emigrants or such other authority as may be prescribed.
- Aid and advise, so far as reasonably as one can, emigrants who have returned to India.

5. Applications, in the attached proforma, are invited from officers holding analogous post on a regular basis in the Central/State Government Ministries/Departments for the above vacancies through proper channel. An advance copy may also be sent by applicants directly for this Ministry's information. The applicant should be clear from vigilance angle. The extant guidelines of DoPT related to deputation will be applicable for the deployment of officials in PoE offices.
6. Duly filled in applications along with Vigilance and Cadre Clearance and certified copies of previous 5 years APARs should reach US (PF & PG), Ministry of External Affairs, New Delhi, latest by **8<sup>th</sup> September 2023**. Applications should be sent by email at [uspf@mea.gov.in](mailto:uspf@mea.gov.in) & [aopg@mea.gov.in](mailto:aopg@mea.gov.in). Hard copies of the application may be sent by registered post to the following address: US (PF & PG), Room No. 4071, Jawaharlal Nehru Bhawan, Ministry of External Affairs, New Delhi.
7. Applications received after the last date will not be considered. The officers/officials will not be allowed to withdraw their candidature after the expiry of the last date of submission of application.
8. Officers must ensure timely submission of the requisite APARs, Annual Property Returns and details of minor/major penalty imposed, if any, on the officer by the competent authority, as these will be taken into consideration for posting to PoE offices.
