In suppression of ACP Order no. 179 dated 29.12.2021 issued vide No.F.4(31)/2021/ACP/Services/DKB/1045-53 dated 29.12.2021 and the recommendations of the Screening Committee constituted for grant of financial upgradation under the Assured Career Progression Scheme (ACP) to the then Gr. III/UDC in accordance with the instructions contained in OM NO. 35034/1/97-Estt.(D) Dated 09/08/1999 issued by Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training) of Govt. of India and Circular Dated 19.02.2020 regarding counting of past service & the policy circular dated 03.06.19 for ACP benefits to official re-deployed/En-cadre from Delhi Khadi Board (DKB)/DRDA/SDAC/DUDA etc), Secretary (Services) is pleased to grant benefits of 1<sup>st</sup> financial upgradation under ACP Scheme to Sh. Sudhir Kumar Tyagi, En-cadre from DUDA and having completed 12 years of Regular Service at DUDA itself from the pay scale of Rs 4000-6000 (S-7) to immediately next higher pay scale i.e Rs. 4500-7000/- (S-8) in the hierarchy of pay scales prescribed in the Annexure-II of DoPT, GOI O.M No. 35034/1/97-Estt (D) dated 09/08/1999 till service period rendered at DUDA in accordance to the Conditions No.7 of Annexure -I of DoPT, GOI O.M. Dated 09.08.99 and the ACP benefits revised as per promotional hierarchy of DASS cadre, i.e. Gr.II (DASS)/Head Clerk in the pay scale of Rs. 5500-9000 (S-10) from the date of En-cadre in GNCT of Delhi w.e.f. the date and pay scale mentioned against his name:-

The grant of ACP is further subject to the condition that:

- 1) The Official concerned may be allowed to exercise his options, if any, under FR 22 within one month of the issuance of the Order granting the financial upgradation under the Assured Career Progression Scheme.
- 2) The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from his pay.
- 3) It should be ensured by concerned Head of Department that the above-mentioned Official is absolutely clear from vigilance angle at all levels and is not under the currency of penalty, at the time of release of financial benefits. Integrity Certificate in prescribed format should also be checked & verified by Head of Department.
- 4) The concerned Head of Department is requested to issue formal order for grant of the 1<sup>st</sup> financial upgradation under ACP Scheme in respect of the above-mentioned Official after verifying and checking the service particulars with regard to date of appointment etc as mentioned above are correct and also after ensuring that all the conditions prescribed above have been fulfilled and complied with discrepancy, if any be brought to notice of this Department and the orders in respect of such Official may not be implemented till clarification from this Department.
